## CONTRACT AMENDMENT

## CONTRACT NAME: INMATE TELEPHONE AND VIDEO VISITATION

AMENDMENT NUMBER: 5

This amendment is made to Inmate Telephone and Video Visitation (Contract) between the State of North Dakota, acting through its Information Technology Department in cooperation with the Office of Management and Budget State Procurement Office (STATE), and Securus Technologies, LLC (CONTRACTOR).

The parties agree to the following terms and conditions and expressly agree that if any of the following terms and conditions conflict with any of the terms and conditions of the Contract, then, notwithstanding any term in the Contract, the following terms and conditions govern and control the rights and obligations of the parties.

The parties agree to amend the Contract as follows:

## Scope of Services

<u>Term and Termination</u>. Notwithstanding anything to the contrary, the terms and conditions of the Amendment shall continue to apply for so long as CONTRACTOR continues to provide the Tablet Trial Program to the STATE after the expiration or earlier termination of this Amendment.

<u>Tablet Trial Program</u>. CONTRACTOR will deploy and make available for sale to inmates its JP6 tablet hardware as a pilot program. The end user price for the JP6 tablet hardware will be \$119.00, plus tax. For an initial period of 60 days (a) End users upgrading from a JP5 will be offered a 50% credit toward the price of the JP6; and (b) end users upgrading from a JP5 mini will be offered a 30% credit toward the price of the JP6. The Tablet Trial Program provided by this Amendment will be provided at no cost to the STATE.

The pilot deployment of the JP6 will contain applications, content, pricing, and compensation which is in accord with that of the previously deployed tablets, provided that additional features and functionalities may be deployed on the JP6 tablets by mutual agreement of the parties. Unless specifically stated otherwise herein, CONTRACTOR's provision of the JP6 tablets will be governed by the same terms and conditions in the Agreement which apply to the previously deployed tablets.

All other terms of the Contract remain in effect. This Contract Amendment is not effective until fully executed by all parties.
