

MASTER SERVICES AGREEMENT

This Master Services Agreement ("Agreement") is made by and between "GTL," which refers to Global Tel*Link Corporation on behalf of itself and its affiliates identified in the applicable attached Service Schedules (individually and collectively, the "Company"), and the County of Columbia, NY, on behalf of the Columbia Sheriff's Department, with its principal place of business at 85 Industrial Tract, Hudson, NY 12535 (the "Premises Provider") (Company and Premises Provider collectively, the "Parties" and each a "Party"). This Agreement is binding upon execution of the named Parties as of the last date signed by the Parties ("Effective Date").

Any GTL Affiliate may sign a Service Schedule in its own name and such Service Schedule will be considered a separate, but associated, contract incorporating this Agreement and the Terms and Conditions; provided, however, that GTL shall be responsible for its Affiliates' performance pursuant to such Service Schedule. "Affiliate" means any entity that controls, is controlled by or is under common control with GTL.

1. **Services.** This Agreement applies to the supply, installation, management, operation, and maintenance of the equipment furnished and services provided by the Company as listed and described in each of the attached Service Schedules (collectively, "Services"). This Agreement establishes the terms and conditions under which the GTL entities will provide Services to Premises Provider at Premises Provider locations ("Facilities"). Each Service listed in the Service Schedules contains specific terms and conditions which shall be incorporated by reference into this Agreement. The Service Schedules indicated below are incorporated into this Agreement. Additional Service Schedules may be incorporated at a later point upon written agreement of the Parties. Service Schedules shall apply to Services located at Premises Provider Facilities, whether existing, newly installed or renovated.

o **Inmate Telephone Services**

Each GTL Affiliate contracting under this Agreement is only responsible for the performance of the Services as set forth in this Agreement and the relevant Service Schedule, and is not responsible for performance of any other Affiliate's obligations thereunder.

2. **Term.** This Agreement shall be in effect for ~~three~~ **five (5)** years, commencing from the Effective Date ("Term"). Unless either party notifies the other in writing of its intention not to renew this Agreement at least ninety (90) days from the end of the original or any renewal term, this Agreement shall automatically renew for additional one (1) year terms (each a "Renewal Term").
3. **Entire Agreement.** This Agreement consists of the attached Terms and Conditions, all Service Schedules, GTL's international, interstate, and intrastate tariffs and published rates, terms, and conditions (collectively, "Tariffs") that may govern the Services and are incorporated by reference into the Agreement. This Agreement and the above referenced attachments constitute the entire agreement between Premises Provider and the Company, and supersedes all other agreements between the Parties pertaining to the subject matter hereof. GTL may modify the Tariffs from time to time, and any modification will be binding upon Premises Provider upon the effective date of the Tariff revision as provided for under the rules of the applicable regulatory authority with which the Tariff is filed. If a conflict arises, the order of precedence is: (i) Tariffs to the extent they are required to take precedence by law; and (ii) this Agreement. In the event of a


conflict or inconsistency between the terms set forth in the Agreement including the Terms and Conditions and a Service Schedule, the terms of the Service Schedule shall control.

4. This Agreement may be executed in multiple counterparts, each of which shall be an original, and all of which shall be one and the same contract.


