As of August 1, 2021, \$.14/minute intrastate using a debit or prepaid, \$.14/minute interstate using a debit or prepaid, \$.14/minute interstate and intrastate collect, and \$.50/minute for international rates. Commission rate reduced from 17% commission on all calls as of August 1, 2021. Securus will provide one free ten-minute phone call per incarcerated individual per week, provided that, for any given account, if the free phone call is not used during that week, the end user will not retain such free calls for that account whenever the next distribution of free phone calls occurs. The free calls described in the November 4, 2020 amendment will no longer be provided. No fees to inmate, family or friends.

CONTRACT CONDITIONS:

The contracts maximum obligation is not to be exceeded, without prior approval of the Chief of Staff, or the Director of Finance. It should not be assumed that a vendor will receive payments up to the maximum amount in a given contract period. This contract may be amended in whole or in part at any time by the NSO, this includes the right of cancellation. COMMENTS:
