INMATE TELEPHONE LOCATION AGREEMENT

- 2. The lease payment shall be for each inmate telephone installed in the location.
- 3. LESSEE shall pay LESSOR a percentage of the gross revenue derived from the operation of the Phones in return for the exclusive right to install and operate the Phones in the premises. Payments to LESSOR shall be on a monthly basis within thirty days after the end of each calendar month. The commission payment shall be as per the attached schedule. (X) OPTION A: Gross revenue shall include all of the revenue generated from the actual call traffic from the facility. Or (__) OPTION B: Gross revenue shall include all of the revenue generated from the actual call traffic from the facility plus processing fees.
- 4. LESSEE shall, at its sole expense, cause collections to be made from the Phones on a regular basis and shall provide LESSOR, a monthly billing and collection report, certified by an officer of Lessee. Reports shall be in a form and contain sufficient information to allow LESSOR to reasonably monitor and calculate compensation due from LESSEE under the terms of this Agreement.
- 5. LESSOR and LESSEE hereby agree that: LESSOR shall notify LESSEE of any malfunction of loss if inmate telephone service and shall allow LESSEE access to LESSOR'S place of business during normal business hours for inmate telephone repair, maintenance and collection. Lessee shall promptly repair or replace faulty equipment and otherwise assure inmate telephone service is available at all times.

- (B) LESSOR shall exercise reasonable care in preventing damage or destruction to the inmate telephone installed under this Agreement but shall not be liable or responsible for such loss, damage or destruction unless caused by the willful conduct of LESSOR.
- (C) The location of the inmate telephones and the space provided shall be such as to make the service available to the jail population and no action which prevents or adversely affects the use of the inmate telephone will be take by LESSOR or its employees except that access can be unilaterally restricted for disciplinary or security reasons.
- (D) All phones, wiring, if any, shall be installed by LESSEE at its expense and LESSOR hereby authorizes LESSEE to contact the local Telephone Company to arrange for removal of existing inmate telephones and the installation of necessary phone lines at LESSEE'S expense. LESSEE shall install telephones at locations specified by LESSOR.
- (E) All inmate telephone and other equipment, fixtures and supplies furnished by LESSEE shall remain its property. Upon termination of the Agreement LESSEE shall have the right to enter upon the location to remove all of its property and shall do so upon request of LESSOR.
- (F) Should LESSOR or LESSEE default in performance of this Agreement or materially breach any of its provisions, either party may terminate this Agreement upon ninety (90) days written notice, if such breach is not remedied by the LESSEE or LESSOR within ninety (90) days of written notice to the party of such a breach.
- (G) This is the sole agreement between the parties hereto superseding all previous agreements and shall bind the parties, their successors and assigns. Each acknowledges the receipts and retention of a fully executed copy hereof.

New Rates and Changes for 6/20/2016

These are the changes to the Reliance inmate telephone business. We have purposely waited until now to release the new rates waiting for any last minute changes by the Federal Court or the FCC. Information below is how the rates and associated charges will be from the above date forward until more changes or court rulings are implemented.

- 1. No flat rate calling for any type of calls. Local, Intrastate, and interstate
- 2. No surcharges on any type of calls, local, intrastate, and interstate.
- 3. Collect local calls are billed at \$0.25/minute.
- 4. Collect Intrastate calls are billed at \$0.40/minute
- 5. Collect Interstate calls are billed at \$0.25 and includes the \$0.04 for the FCC (FUSF) charges
- 6. Phone card rates for local calls are at \$0.40 or \$0.50 depending which rate plan you have chosen.
- 7. Phone card rates for Intrastate calls are at \$0.40 or \$0.50 depending which rate plan you have chosen.
- 8. Phone card rates for Interstate calls are at \$0.25 and include the \$0.04/minute FCC (FUSF) charge.
- 9. Reliance does not have a minimum payment for collect call accounts.
- 10. Reliance automated payment fee is \$3.00 plus 3.3% for credit card fees.
- 11. Reliance Live Agent fee is \$5.95 plus 3.3% for credit card fees.

We have enclosed laminated labels to be attached to the existing blue instruction cards in the day areas by each inmate telephone. Please place the label over the rates that are listed on the blue card now. If there isn't a blue instruction card please apply it to the telephone.
