

CONTRACT AMENDMENT

CONTRACT NAME: INMATE TELEPHONE AND VIDEO VISITATION

AMENDMENT: 10

This amendment is made to Inmate Telephone and Video Visitation (Contract) between the State of North Dakota, acting through its Information Technology Department in cooperation with the Office of Management and Budget State Procurement Office (STATE), and Securus Technologies, LLC (CONTRACTOR). This Amendment will be effective as of the last date signed by either party (the "Effective Date").

The parties agree to the following terms and conditions and expressly agree that if any of the following terms and conditions conflict with any of the terms and conditions of the Contract, then, notwithstanding any term in the Contract, the following terms and conditions govern and control the rights and obligations of the parties.

The parties agree to amend the Contract as follows:

1. CHANGES TO ITS PRICING FOR INDIGENT INMATES

CONTRACTOR has 90 days of the Effective Date, to implement the ability to offer two free 15-minute phone calls per month for indigent inmates to contact their children on the approved phone list.


- a. An indigent inmate is defined as one who receives \$15 or less of spendable money each month, including spending balances carried over from the previous month.
- b. To qualify, an inmate must be actively seeking a job and cannot have quit a job, refused to work, or have been fired from a job or work assignment within the past 30 days.

2. CHANGES TO SVV PRICING

CONTRACTOR has 90 days of the Effective Date, to implement the ability to offer two free video visitation sessions per month to inmates actively working towards family unification within their case plan.

All other terms of the Contract remain in effect. This Contract Amendment is not effective until fully executed by all parties.
