RESOLVED, by the Wayne County Commission this 20th day of January, 2022 that approval be, and is hereby, granted authorizing Amendment No. 4 to a contract with a one-year option to renew between the Charter County of Wayne and Team Mental Health Services dba Team Wellness Center (of Dearborn) not to exceed \$87,500 to increase compensation in Fiscal Year 2021-2022 to continue providing community-based, residential rehabilitation treatment and services for adult offenders released from the Wayne County Jail who are homeless, or are diagnosed with mental health or substance use disorders, and require residential rehabilitation services for successful re-entry to the community, as recommended by the Chief Executive Officer; and be it further

RESOLVED, that Amendment No. 4 increases the total contract not-to-exceed amount from \$487,500 to \$575,000; the term of the contract remains from July 12, 2018 through April 1, 2022 and the cost of Amendment No. 4 will be charged to Account No. 101 35104 815002 (Residential Outplacement); and be it further

RESOLVED, that the Chief Executive Officer be, and is hereby, duly authorized to execute the aforementioned Amendment No. 4 on behalf of the Charter County of Wayne.

**AMENDMENT NO. 2 BETWEEN

This Amendment #2 between the County of Wayne, Michigan, a body corporate and Charter County acting through its Department of the Sheriff ("County") and Telmate, LLC, a Delaware limited liability company ("Contractor") which extends and modifies the original Contract (2018-71-003) approved by the Wayne County Commission on January 25, 2018 by Resolution No. 2018-013 and Modification No.1 approved by the Wayne County Commission on December 19, 2019 by Resolution No. 2019-949.

RECITAL

The parties wish to extend their agreement for two (2) years.

IT IS AGREED THAT:

1. Section **8.01** is amended from:

3. Appendix D-1 shall be added to the Contract and shall be in effect for the Renewal Term.
4. All other terms and conditions of the Contract shall remain in full force and effect.
5. Each party warrants that its agent signing this Amendment is authorized to bind its principal.
6. This Amendment is subject to the County's policies regarding modification of contracts.
7. This Amendment shall become part of the Contract between the parties.



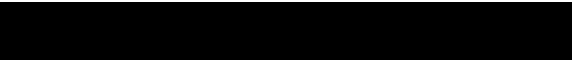

Re: Change to Inmate Telephone Service Rates

Dear Sir or Madam:

Telmate, LLC ("Telmate" or the "Company" or the "Contractor") and the County of Wayne, a body corporate and Charter County, acting through the Office of the Sheriff (the "Premises Provider" or "County") are parties to a certain Inmate Telephone Services Contract dated January 25, 2018, as amended from time to time (the "Agreement").

Effective October 26, 2021, Telmate must make certain changes to inmate telephone service rates and ancillary service charges mandated by the Federal Communications Commission ("FCC") Third Report and Order, Order on Reconsideration, and Fifth Further Notice of Proposed Rulemaking issued in WC Docket No. 12-375 on May 24, 2021 ("FCC Order").

As you know, the parties have been in discussions over the past several months regarding modifications to the Agreement necessary to comply with the FCC Order. Unfortunately, the parties have not had sufficient time to execute a formal amendment to the Agreement. The law requires the Company to implement the certain changes to inmate telephone service rates and ancillary service charges or face steep penalties imposed by the FCC for failure to comply with the law. Consequently, based on the change in law, the Company will implement the following changes effective October 26, 2021:

1. In compliance with the FCC Order and FCC Rule 64.6020, Ancillary Service Charges shall be no more than the following amounts effective October 26, 2021, or the effective date of the FCC Order, whichever is later:

Automated payment for credit card, debit card, and bill processing fees	\$3.00 per transaction
Use of live operator	\$5.95 per transaction



Paper bill/statement	\$2.00 per transaction
Use of third-party money transmitter (<i>e.g.</i> , MoneyGram, Western Union, credit card processing, transfers from third-party commissary accounts)	\$6.95 per transaction
Use of single-call and related services to pay for a single ITS call using debit/credit card, mobile phone account, or another arrangement	\$6.95 per transaction, plus the adopted per-minute rate

2. In compliance with the FCC Order and FCC Rule 64.6030, effective October 26, 2021, or the effective date of the FCC Order, whichever is later, the rates and charges for international, interstate, and intrastate inmate telephone service ("ITS") calls shall be:

Interstate ITS calls, whether made using a collect, debit, or prepaid/AdvancePay™ format: \$ 0.16 per minute of use.

Intrastate ITS calls, whether made using a collect, debit, or prepaid/AdvancePay™ format: \$ 0.28 per minute of use.

International ITS calls, whether made using a debit or prepaid/AdvancePay™ format: \$0.16 per minute of use.

No per call, per connection, or flat-rate calling charges shall apply to international or interstate ITS per minute of use calls.

The ITS rates set forth above are exclusive of taxes and other amounts collected by the Company on behalf of, or paid to, third parties, including but not limited to payments in support of statutory or regulatory programs mandated by governmental or quasi-governmental authorities, such as the Federal Universal Service Fee, and any costs incurred by the Company in connection with such programs.

We look forward to continuing to work with you and support you and the community you serve. We are ready to work with you at your convenience to finalize an amendment to the Agreement to the extent necessary. Thank you for your cooperation on this matter.
