

**AMENDMENT NO. 2 TO MASTER LICENSE AND SERVICES AGREEMENT
BETWEEN HOMEWAV, LLC AND THE LIBERTY COUNTY (GA) SHERIFF'S OFFICE**

THIS AMENDMENT, is made and entered into this 30th day of September 2022, between the Liberty County (GA) Sheriff's Office through its authorized representative (the "County") and HomeWAV, LLC, a Delaware limited liability company ("HomeWAV").

WHEREAS HomeWAV, LLC and the County are parties to the certain Master License & Services Agreement, dated as of April 12th, 2021 ("MSA") and an Amendment #1 to the MSA, dated as of March 11th, 2022.

WHEREAS the parties mutually agree to amend the contract to reflect the new information related to additional services, term, and usage fee modifications.

NOW THEREFORE, the parties hereto, intending to be legally bound, hereby do agree to the following amendment:

- Additional Services Provided. HomeWAV agrees to activate the Argus Investigative Platform and Transcription add-on at no additional cost to the County.
- Usage Fees. The Facility's inmates shall be charged the following fees for using the System, or such other prices as may be agreed to by the County and HomeWAV (such amounts, the "Usage Fees").



3. Term. This amendment shall become effective on the date of last signing and shall renew and extend the agreement between the parties through December 31st, 2024, unless terminated earlier pursuant to Section 15 of the MSA; provided, however, that this agreement shall automatically extend for additional terms of one (1) year unless either party notifies the other party of its desire to terminate this Agreement no later than ninety (90) days prior to the end of the then-current term.


