**AMENDMENT TO THE INMATE  
TELEPHONE SERVICES  
AGREEMENT**

THIS AMENDMENT TO THE INMATE TELEPHONE SERVICES AGREEMENT ("Amendment") is entered into as of the date of last signature of this Amendment (the "Effective Date"), by and between Global Tel\*Link Corporation, having its principal place of business at 3120 Fairview Park Drive, Suite 300, Falls Church, VA 22042 ("Company") and the County of Saratoga, acting by and through its Saratoga County Sheriff's Office, with an address of 6010 County Farm Road, Ballston Spa, NY 12020 ("county" or "premise provider").

WHEREAS, Company and Premise Provider previously entered into the Inmate Telephone Services Agreement dated October 10, 2014 ("Agreement") and the parties would like to further amend the Agreement as provided for herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations set forth below, and for other good and valuable consideration the sufficiency of which is acknowledged by the parties, the parties hereby amend the Agreement as follows:


1. Section 4. Compensation is hereby amended to (a) increase the phone commission paid to County by Company from fifty-five percent (55%) to eighty percent (80%) upon execution of this Amendment and (b) change all domestic call rates to twenty cents (\$0.20) per minute.
2. Except as set forth above, there is no other revision to the Agreement or the obligations of either party, and the Agreement remains in full force and effect.
3. In the event of any inconsistencies between the terms and conditions contained in the Agreement and the terms and conditions contained in this Amendment, the terms and conditions contained of this Amendment will control.
