“documents detailing all payments made; by or on behalf of any inmate telephone and/or video communication service provider”; fiscal years 2014-2018

Please be advised that I have included the records that exist / we possess that you have requested. I have included statements from NCIC Inmate Phone that we receive for billing purposes on behalf of our inmate phone service vender Michigan Paytel. This Office started receiving the above statements in March of 2018. I have included those requested statements from March 2018 through December 2018. Detailed documents prior to March 2018 do not appear to exist at this office. You may wish to contact Michigan Paytel directly at 248-626-5050 for pre 2018 detailed statements, if the exist.

In the event you are not satisfied with this response, I want to advise you of your rights. You have the right to submit a written appeal to the head of the Manistee County Sheriff's Office, who is Sheriff John O'Hagan, that specifically states the word “appeal” and identifies the reason or reasons for the reversal of this denial by myself.

In addition, you may also seek judicial review of this denial pursuant to MCL 15.240. If you seek judicial review and the Court determines that the public records are not exempt from disclosure, you have the right to receive attorney fees and damages
