This contract modification is entered into pursuant to Attachment I; paragraph J, Changes to the Contract, of the MOU dated 12/15/2013.

Description of Modification:

1. Effective immediately, the following commodity shall be added to the JPay products available for purchase: JP5S 7" Tablet. See **Attachment A** for additional specifications.
2. The Contractor shall pay the Virginia Department of Corrections a commission of \$5.00 for every tablet sold. The commission is inclusive of total tablet price of \$129.99.
3. Under MOU/Contract DOC-14-074, paragraph E, the following shall be added, as shown in bold in Line 1:

**B. PRICING AND COMMISSION**

Pricing will be reasonable and conform to market value as evaluated by the DOC.

1. Commissions: Purchasing music/audio file/games/E-Books and other media added as requested -5% per item
2. Purchasing playing device (MP3, MP4) -\$5.00 per device.
3. **Purchasing 7" tablet device (JP5S) -\$5.00 per device.**
4. Email (outbound message) - .05 (5 cents) per outbound message.

Except as provided herein, all terms and conditions of contract DOC-14-074, dated 12/15/2013, Modification 001, dated 11/25/2014, Modification 002, dated 3/2/2015, Modification 003, dated 12/2/2015, Modification 004, dated 10/5/2016, Modification 005, dated 12/7/2016 and Modification 006, dated 12/28/2016 is heretofore changed, remain unchanged and in full force and effect.
