This contract modification is entered into pursuant to Memorandum of Understanding, Attachment 1, Paragraph K, of the General Terms and Conditions.

Description of Modification, all of which are effective beginning December 1, 2015:

1. Delete the current phone rates and replace with the following:



2. Effective 30 days after this modification, the DOC shall pay the Contractor a one-time payment of \$250,000 to offset the capital costs related to the above phone rate reductions. The payment shall be made to the Contractor by January 31, 2016.
3. In addition to the above payment, the DOC shall pay the Contractor \$250,000 every 90 days for annual software licensing costs to offset the software licensing costs related to the above phone rate reductions. The payments shall be made by March 31, 2016, June 30, 2016, September 30, 2016, and December 31, 2016.
4. Delete commissions from the contract.
5. Whereas the Commonwealth desires to extend the performance period of the contract, now therefore it is agreed that the contract performance period shall be extended through November 30, 2016.

Except as provided herein, all terms and conditions of contract DOC-05-005 dated October 18, 2005, as heretofore changed, remain unchanged and in full force and effect.
