**DESCRIPTION OF ITEMS CONTRACTED**

Contract to provide Tablets and media services to Iowa Prison Industries, Canteen division. For sale to Iowa DOC incarcerated individuals. This contract is issued as a Sole Source procurement. The term of the contract is for one year or until a new tablet program is implemented, whichever comes first. At minimum, the DOC will provide ATG tablets for 6 months. If a new Tablet program is not established within 6 months the DOC will continue with ATG as the supplier of Tablets and media services until the new tablet program is implemented. The contract can be renewed yearly. The parties agree to comply with the terms and conditions on the following attachments which are by this reference made a part of the Agreement.

- Tablet \$135 (includes SCORE7T, charger and headphone).
- Replacement chargers and headphones are \$9 each.
- (Optional, available if IPI wants it) Keyboard \$22
- For the first year all media price remains as listed below.
  - Songs -- \$1.75 each
  - Games – Between \$1 - \$4 depending on the game.
  - Movie Rental – Between \$3 - \$5 depending on movie.
- ATG will deinstitutionalize the tablet for \$35 paid by the incarcerated individual. This process replaces the secure firmware with a non-secure firmware which allows the user to freely connect to other devices using USB, Wi-Fi, or Bluetooth, etc. The incarcerated individual's purchased content is left intact.

**IPI earnings**

- Starting the day after 1000 new tablets have been activated by incarcerated individuals and \$600,000 in media sales. ATG will rebate IPI 4% of all media sales. Media rebate will be paid monthly for sales completed the previous calendar month. Rebate will be paid within 10 business days of the new month by check to IPI.
- IPI will sell hardware to inmates at prices above, will order hardware in bulk (each box contains 48 tablets) from ATG at \$110. Hardware will be delivered within 7 days of order. Like before, hardware has 90-day warranty from date of sale. ATG will take back any unsold tablet in original packing within 90 days of purchase, and issue IPI full credit for returned tablets.


